



LIMITED WARRANTY

This limited warranty shall be constructed under the law of the State of Maryland.

For one (1) year from the date of purchase, BEAMHIT will repair or replace and return the BEAMHIT™ target or other components, excluding the laser transmitter, to the original purchaser, free of charge, if defective in material or workmanship.

For ninety (90) days from the date of purchase, BEAMHIT will repair or replace and return the BEAMHIT™ laser transmitter to the original purchaser, free of charge, if defective in material or workmanship.

THIS WARRANTY DOES NOT COVER DAMAGE OCCURRING IN SHIPMENT OR PRODUCT FAILURE RESULTING FROM ALTERATION, ACCIDENT, MISUSE, ABUSE, NEGLIGENCE, AND/OR IMPROPER INSTALLATION AND/OR MAINTENANCE.

LIMITATION OF WARRANTY: EXCEPT AS OTHERWISE EXPRESSLY PROVIDED BY LAW, THE FOREGOING WARRANTY OF REPAIR OR REPLACEMENT IS THE SOLE AND EXCLUSIVE WARRANTY APPLICABLE TO THE PRODUCT. THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE DESCRIPTION ON THE FACE HEREOF. THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

BEAMHIT CUSTOMER SERVICE WILL NOTIFY YOU OF ANY NECESSARY REPAIRS TO THE PRODUCT, WHICH REPAIRS BEAMHIT WILL PERFORM FOR AN ADDITIONAL CHARGE OF \$50.00 PER HOUR (YOUR INITIAL \$25.00 NON-REFUNDABLE FEE WILL BE CREDITED TO THE COST OF SUCH REPAIR).

To make request or claim for repair of service under this limited warranty, the original purchaser must return the product to the manufacturer, shipping prepaid, and adequately insured and in its original box or equivalent, or to an authorized Service Center and assume the risk of loss or damage in the transit.

A written receipt or duplicate copy for the product, showing the date of purchase and the dealer or distributor's name must accompany any request or claim for work to be performed under this limited warranty.
